



Acknowledgement of Volunteer Responsibility, Express Assumption of Risk, and Express Release of Liability

In consideration for being allowed to participate as a volunteer for C-U at Home on behalf of myself and my next of kin, heirs and representatives, I release from all liability and promise not to sue C-U at Home and collectively its' contractors, employees, officers, directors, staff, volunteers and agents, and all property owners, including their contractors, employees, officers, directors, staff, volunteers and agents, on whose property my volunteer services take place on, from any and all claims, including but not limited to intentional or unintentional acts, claims of negligence, resulting in any physical or psychological injury (including paralysis and death), illness, damages or economic or emotional loss I may suffer because of my participation as a volunteer, including travel to and from and during any volunteer activity.

I am voluntarily participating as a volunteer. I am aware of the risks associated with working with the Homeless along with the problems that many of the Homeless have including but not limited to drug addiction, alcohol addiction, and mental illness. Those risks include but are not limited to physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability (including paralysis), economic or emotional loss, and/or death. I understand that these injuries or outcomes may arise from my own or other's actions, inaction, or negligence; conditions related to travel; or the condition of the volunteer location(s). Nonetheless, I assume all related risks, both known or unknown to me, of my voluntary participation as a volunteer, including travel to, from and during any volunteer activity.

I agree to hold C-U at Home, and all property owners on whose property my volunteer services take place on, harmless from any and all claims, including attorney's fees or damage to my personal property that may occur as a result of my voluntary participation in this activity. If C-U at Home incurs any of these types of expenses, I agree to reimburse C-U at Home. If I need medical treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

In consideration for my acceptance as a volunteer with C-U at Home, and the services and amenities to be provided by C-U at Home in connection with their work, I confirm my understanding that:

- I have read any rules and conditions applicable to my volunteering role made available to me and I acknowledge my participation is at the discretion of C-U at Home.
- This Agreement is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.
- To the fullest extent allowed by law, I agree to WAIVE, DISCHARGE CLAIMS, AND RELEASE FROM LIABILITY C-U at Home, its officers, directors, employees, agents, and leaders from any and all liability on account of, or in any way resulting from Injuries and Damages, even if caused by negligence of C-U at

Home, its officers, directors, employees, agents, and leaders, in any way connected with C-U at Home. I further agree to HOLD HARMLESS C-U at Home, its officers, directors, employees, agents, and leaders, and all property owners on whose property my volunteer services take place on, from any claims, damages, injuries or losses caused by my own negligence while a volunteer. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators and assigns.

- I have read this document in its entirety and I freely and voluntarily assume all risks of such Injuries and damages and notwithstanding such risks, I agree to participate as a volunteer.

I acknowledge that while participating or volunteering, C-U at Home cannot guarantee that I will not become infected with COVID-19. Further, participating in events held by C-U at Home could increase my risk of contracting COVID-19. By signing this Agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my participating in any C-U at Home event or programming ("Claims"). I hereby release, covenant not to sue, discharge, and hold harmless C-U at Home, its employees, agents, and representatives, and all property owners on whose property my volunteer services take place on, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of C-U at Home, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any C-U at Home program or event.

I do hereby consent and agree that C-U at Home, its employees, or agents have the right to take photographs, videotape, or digital recordings of me whenever I am acting as a volunteer for C-U at Home and to use these in any and all media, now or hereafter known, and exclusively for the purpose of C-U at Home. I further consent that my name and identity may be revealed therein or by descriptive text or commentary.

I do hereby release to C-U at Home, its agents, and employees all rights to exhibit this work in print and electronic form publicly or privately and to market and sell copies. I waive any rights, claims, or interest I may have to control the use of my identity or likeness in whatever media used.

I am 18 years or older. I understand the legal consequences of signing this document, including (a) releasing C-U at Home from all liability, (b) promising not to sue C-U at Home, (c) and assuming all risks of voluntarily participating as a volunteer, including travel to, from C-U at Home.

I understand that this document is written to be as broad and inclusive as legally permitted by the State of Illinois. I agree that if any portion is held invalid or unenforceable, I will continue to be bound by the remaining terms.

I have read this entire document and I am signing it freely. No other representations concerning the legal effect of this document have been made by me.
